✓ Applications For Remarks Must Be Submitted By 03 November 2017 – please note further that -

- **Candidates who have already attended their orals are not entitled to request a remark.**
- Candidates who are dissatisfied with their marks in any section of the examination may have their paper remarked.
- Please note that the procedure to request a remark is as follows:
 - ✓ a completed application form must reach the Society within one week of the results becoming available. Please note that the closing date for remark requests in respect of the abovementioned examinations is **03 November 2017**
 - ✓ a remark fee, equivalent to twice the initial registration fee, is payable for the section of the examination in which the remark is requested. If the remark is successful in that the status changes (e.g. from a failed mark to a pass mark or from a failed mark to an oral with a subsequent pass), this fee will be refunded on written request of the applicant.
- Please note that remark result will be binding as follows:
 - ✓ **0% to 39%: Fail**
 - ✓ **40% to 49%: Oral**
 - ✓ **50% and above: Pass**
- **The remark results will be published on 17 November 2017 at 14:00.**
- Remark Orals in respect of candidates from all other venues will be advised by the relevant Convenors.
- Thus, although a candidate may lose the initial oral as a result of the request for remark, he/she might still qualify for a remark oral (which is essentially the same as an oral), provided that a mark of between 40% and 49% is obtained on remark.
